MIE - Marine Industry Enhancement Activities

Marinas face many challenges: rising operating costs, decreasing fish populations, a decline in participation in boating and fishing and a weak economy. To help address these issues, the New Jersey Department of Transportation's [I Boat NJ](#) Program recently awarded over \$400,000 to the New Jersey Marine Sciences Consortium (NJMSC)/New Jersey Sea Grant Program (NJSG) to conduct activities to enhance the marina industry and expand the [New Jersey Clean Marina Program](#).

The Marina Industry Enhancement (M.I.E.) component of the award includes funding for activities such as providing technical assistance on vessel wash water systems and other items, funding for best management practices (BMPs), media events and other items. Additional topics on the M.I.E. website include information on:

Storm Water Permit

The NJDEP has proposed a permit-by-rule for the construction and/or installation of vessel wash wastewater systems and associated infrastructure that prevent any discharge of vessel wash wastewater into the waters of the State at marinas, boatyards and boat sales facilities. The permit-by-rule would be available to any marina, boatyard or boat sales facility that installs a vessel wash wastewater system, including those necessary to comply with the Basic Industrial Stormwater General Permit and those not subject to the Stormwater General Permit but that wish to voluntarily install such systems.

The permit-by-rule enables marinas to install a vessel wash wastewater system and any related infrastructure **without** having to obtain a coastal or general permit as long as the guidelines in the permit are followed. Marinas will need to verify if any local permits are needed but they will not need an NJDEP permit. A copy of the rule can be downloaded at nj.gov/dep/rules/notices/080408b.html.

Public Access & Marina Safety Taskforce Act Becomes Law

On September 10 2008, Governor Corzine signed S1553- the Public Access & Marina Safety Taskforce Act into law.

The Public Access & Marina Safety Taskforce Act takes effect immediately and establishes a moratorium on the implementation of the NJDEP public access rules for marinas. For the duration of the moratorium, the NJDEP shall not (1) require a marina facility to provide unlimited public access to the waterfront; (2) require a conservation easement by means of deed restriction; (3) require perpendicular access across the entire waterfront; (4) or require additional parking, as a condition of any permit for activities relating to the expansion or renovation of an existing marina facility. The legislation also establishes a task force that will be responsible for evaluating and studying the efficacy, practicability and feasibility of the rules and regulations governing public access at marinas. The moratorium will be in effect for two years allowing the task force to study the issue and make recommendations to the Governor. CVA Offering Operation and Maintenance Funding for Marinas with Pumpouts

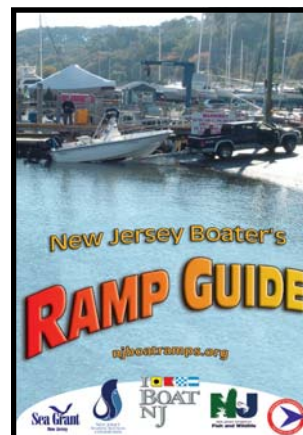
The New Jersey Clean Vessel Act Program is pleased to announce the availability of Operation and Maintenance (O & M) funding to New Jersey marinas. Up to \$1,500 in expenses will be reimbursed per marina for the O & M of pumpout equipment during the 2008 boating season. Marinas can be reimbursed for pumpout staff costs, repairs, maintenance, and boat sewage hauling fees, less any income generated from fees charged for pumpout service.
